# #DEVCON2023: HOMA BAY COUNTY LIGHTS UP DEVOLUTION CONFERENCE

## THE KEY DELIVERABLES FOR THE MINISTERS

As each CECM shook hands with the Governor upon signing their performance contracts, the attention was shifted immediately to what had just been signed and which both parties agreed were to be implemented.

Leading the queue was the Deputy Governor Hon Joseph Magwanga who among other things will formulate, implement, and monitor agriculture and livestock legislation, regulations, and policies; provide financial support in the delivery of crop production, livestock, and veterinary services by use of modernized technologies, innovative procedures, and systems; and scale up livestock and veterinary services for improved animal health and public health, by the renovation of slaughterhouses, construction of sales yards, livestock disease surveillance and vaccination, Training and equipping of Artificial Insemination service providers and meat inspection.

Dr. John Agili will create an enabling environment for the exploitation of water resources by providing infrastructural facilities development at the landing sites, establishing a fish hatchery, conducting monitoring, control, and surveillance, and providing institutional support to Beach Management Units; and providing for installation of outdoor LED screens, create network and internet connectivity to various County Departments, implementation of

an automated revenue collection system, acquire ICT equipment and create Wi-Fi hotspots in public places.

Ms. Roseline Omolo will look into scaling up high-impact interventions at all levels to reduce maternal, neonatal, and child morbidity and mortality; provision of a functional and sustainable infrastructure for comprehensive health services; and expanding access to primary and specialized healthcare. Her Trade counterpart Polycarp Okombo is tasked to increase the traffic of local, national, and international tourists into Homa Bay County besides making Homa Bay a leading investment and trade hub in the region by creating an enabling environment for both.

Dr. Peter Ogola aims to provide a spatial framework to guide and control development in the County; create a conducive and enabling environment for land administration and management; establish and strengthen urban institutions towards sustainable urbanization in the County among other things. Mr. Martin Opere will aim to enhance quality and inclusive education as well as make vocational training more attractive to the youths in Homa County. He will also make sure that innovation is integrated with technology as the focus shifts to digitization and the use of artificial intelligence.

# GOVERNANCE: RING-FENCING INTEGRITY IN THE PUBLIC SERVICE

## GOVERNOR RECEIVES REPORT ON STAFF AUDIT, PROMISES ACTION

H. E. Governor Gladys Wanga received and shared the findings of the first phase of the County Government of Homa Bay Public Service Payroll and Personnel Census Audit from Price Waterhouse Coopers - an internationally credible institution on audit matters. This was an exercise that her administration embarked on at the onset of her tenure, ostensibly to deliberately establish an efficient and effective public service for this great County and its people.

The Governor revealed that Phase One of the exercise focused on the verification of county employees and payroll data. The other two phases will include setting up a clear staff establishment for the County's public service and putting in place a Human Resource Management System that will serve the people of Homa Bay County.

"These two phases will be executed upon the full implementation of the report we have received today. Moving forward, my administration will

embark on both administrative and legal actions starting immediately until all the provisions for this report are fully implemented according to the law," the Governor said as she received the report, flanked by her deputy Hon Oyugi Magwanga.

The report exposed a number of glaring issues including but not limited to staff without any papers to support their recruitment but earning salaries, staff with academic papers that have been confirmed as fake by the Kenya National Examinations Council and other Institutions of Higher learning, staff who have been earning but do not know any of their colleagues just by name leave alone their immediate supervisor, staff who were employed while under age (under 16 years, as per the Act), glaring erratic job grade placement, promotions over and above the most obvious cases of erroneous employment or semblance thereof.

individuals with no files in the County Registry and did not present any relevant documents during the audit.

287

individuals who did not appear **AT ALL** for verification.

556

individuals who did not present any appointment letters or other key employment documents.

10

individuals were caught in a cybercafé in town generating supposed employment documents.

322

individuals who lacked appropriate academic qualifications and/or have been licensed by their respective professional bodies as well as those whose 'certificates' KNEC confirmed as inauthentic.

479

individuals in the payroll earning but cannot be traced to the signed departmental HR lists.

3

individuals earning but under the age allowable for employment by the Act.

The Governor said she will embark on an administrative and legal journey to ensure full implementation of the recommendations is effective immediately until she establishes an efficient and effective public service, which will enable her administration to satisfactorily deliver

on its pledges and promises to the people of Homa Bay.

"At the end, we look forward to making substantive savings on the public resources under our charge as an administration," the Governor concluded.

### CIDP LAUNCHED, PROMISES RENEWED HOPES

**H**oma Bay County unveils 3rd generation CIDP 2023-2027. Governor Gladys Wanga took charge today as the 48.9 billion 3rd Generation County Integrated Development Plan (CIDP) was launched at a colourful ceremony at the Governor's Park in Homabay Town. The five-year comprehensive plan signals the beginning of a crucial blueprint roadmap that will guide the County's economic development for the next five years.

Speaking during the event, Governor Wanga stated that the document was subjected to scrutiny by various stakeholders including members of the public, and the County Assembly, and is centred on the inspiring theme of "unlocking and optimizing the endless potential of the County." The Governor committed plans to focus on quality education and healthcare, modern infrastructure and connectivity, social inclusion and empowerment of communities, good governance and institutional strengthening, sustainable economic growth and public

participation as major issues her Administration seeks to deal with Wanga said despite the scarcity of resources, her Administration will endeavour to equitably allocate the available resources in a bid to achieve equitable development across the County and put in place evaluation systems to ensure timely implementation of projects. The County Chief reiterated her commitment to serving

the people of Homabay and assured them that her Administration will continue to be people centered. “We will ensure increased community ownership through public participation. This people-driven approach reflects our commitment to inclusivity and effective governance,” she said.

She further said that Project management committees are formed on every project to ensure

quality service delivery by contractors to county residents. Deputy Governor Oyugi Magwanga thanked the County Assembly for working closely with the executive to benefit the people. In attendance were Homabay Senator Moses Kajwang’, County MP Dr. Joyce Osogo, CECMs, County officials, representatives from the National Government, and members of the public.

## THE CIDP 2023 - 2027 BREAKDOWN

**W**hen Governor Gladys Wanga launched a 47.5-billion-shilling Homa Bay County’s 3rd Integrated Development Plan (CIDP) in a grand ceremony in Homa Bay Town quite noticeable highlights from it emerged. Here are some of the key projects she aims to accomplish by 2027:

- Invest KES 2 billion to upgrade all 9 sub-county hospitals to Level 4 facilities.
- Allocate KES 2 billion for the Lakefront Development Program, which includes constructing a promenade, parks, beaches, and land banking.
- Implement a comprehensive waste management system, costing KES 2 billion over the next 4 years.
- Allocate half a billion shillings for Natural Resources Management projects in the county.
- Rehabilitate lake transport, refurbishing jetties in Kendu Bay, Homa Bay, Mbita, and Sena. Reintroduce steamer transport and establish sustainable Blue Economy projects, requiring an investment of KES 2 billion.
- Develop Homa Bay County as a prominent tourist destination within the Western Kenya Tourist Circuit, with a budget of KES 500 million.
- Invest KES 2 billion in the County Aggregation and Industrial Park at Riwa, Karachuonyo.
- Establish three fish processing plants in Suba North, Suba South, and Rachuonyo North, with an allocation of KES 100 million. Additionally, allocate KES 50 million for Omena drying facilities in these sub-counties.
- Upgrade slums in Homa Bay, Oyugis, Nyandiwa, and Rusinga, with a budget of KES 50 million.
- Allocate KES 2 billion for the Affordable Housing Project, expanding to Mbita and Oyugis, in addition to the ongoing project in Homa Bay Town.
- Install renewable energy plants on the islands of Kiwa, Ringiti, Ngodhe, and Takawiri, with an investment of KES 400 million.
- Allocate KES 170.6 million for Gwasi Spring Development, KES 150 million for the Rusinga Water Project, and an additional KES 500 million for the Carbon Trading Project, to address climate change challenges.



- Allocate KES 200 million for the County Integrity and Accountability Support Project, aimed at promoting ethics and integrity.
- Construct a new county headquarters in Arujo, costing KES 300 million, and establish ICT and Innovation Hubs in each sub-county, with a total budget of KES 450 million. Additionally, spend KES 260 million on Youth and Women Empowerment Centers in Rodi, Ringa, and Adiedo.
- Construct and upgrade all EYE (Early Years Education) centres in the county, with a budget of KES 960 million. Additionally, allocate KES 500 million for the school feeding program over the next 4 years.

# AGRICULTURE: ENHANCING VALUE ADDITION

## GOVERNOR FLAGS OFF DISTRIBUTION OF AGRICULTURAL INNOVATION GRANT ITEMS TO FARMERS

Under the Agriculture Sector Development Support Programme (ASDSP II), Governor Gladys Wanga recently launched an initiative to provide agricultural value chain grants to farmers in Homa Bay County. The program, developed by the Ministry of Agriculture, Livestock, Fisheries, and Cooperatives in collaboration with 47 county governments, aims to address food and nutrition security while promoting manufacturing. The grants, worth KES 6.7 million, will be distributed to farmers in the horticulture and aquaculture sectors. The funds will be used to improve soil health, enhance post-harvest management, promote proper utilization of farm inputs, and enhance the quality of farm produce.

This initiative is part of a broader effort to enhance the capacity of different actors within the priority value chains in order to overcome the challenges that hinder the commercialization of agriculture. By supporting farmers in key sectors, the program seeks to contribute to the overall development of the agricultural industry and the well-being of farmers in Homa Bay County.

Further, the Governor launched a private sector-led Rapid Soil Testing campaign in Western Counties. The USAID-funded Feed the Future Kenya Crops and Dairy Market System (KCDMS), targets smallholder farmers and aims to transform

agricultural market systems and create an enabling environment for agribusiness by encouraging government-level reforms that foster investment and benefit farmers in the western region.

In alignment with the vision of building resilient and thriving communities, the County Government of Homa Bay through the National Agricultural and Rural Inclusive Growth Project distributed KES 17 worth of cheques to cotton, poultry, dairy, and banana farmers to enhance their agricultural production, raising income levels, ensure food security and improve nutritional outcomes in the county.



## SUPERVISORS, ENUMERATORS TRAINED IN READINESS FOR FARMERS' REGISTRATION

**T**he County Government of Homa Bay has started training supervisors and enumerators for the new profiling and mapping of agricultural stakeholders and value chain actors slated to start in early September.

The training marks the commencement of the farmer registration exercise conducted jointly by the county and national government, facilitating the collection and documentation of vital information regarding farmers and their farming enterprises. Deputy Governor and Agriculture CECM Hon Joseph Magwanga said 8 senior supervisors, 24 assistant supervisors, 40 supervisors, and 503 enumerators had been picked for the

month-long exercise, where they project to register over half a million farmers.

Speaking at Kabunde Social Hall while opening the three-day training for supervisors who will thereafter train the enumerators, Governor Gladys Wanga said it was important to bring them up to speed with what is expected of them during data collection, adding that she expects, at the bare minimum, a total of 400,000 to shall have been registered at the end of the exercise.

She said that by doing so, the government will be able to better understand the needs and challenges faced by farmers in a bid to assist them in making sound decisions aimed at boosting production and incomes.

The Governor said the registration will not only help in the distribution of farm inputs but also help shape agricultural policies, saying that Homa Bay County should now begin thinking of what agricultural crop or value chain it should be known for as a production and market leader.

"It is through the same database and platform that farmers will receive information on techniques to apply on their farms and available markers," she said.

## CLIMATE CHANGE: HOMA BAY COUNTY UNDERTAKES A CLIMATE CHANGE TRAINING PROGRAM.

**T**he County Government of Homa Bay's Directorate of Climate Change concluded a 2-day training session for Ward Climate Change Committee members to sensitize them on their roles and structures.

While presiding over the official closure of the training, the CEC member for Water, Environment, Sanitation, Irrigation, Energy, Forestry, and Climate Change Dr. Joash Aloo stressed that climate change issues are key to the County's Development agenda and urged them to be at the forefront in initiating and implementing climate change initiatives at the grass root level. He also emphasized that the training signifies the County Government's commitment to addressing climate change issues and equipping local communities with knowledge and tools to mitigate its effects to adapt to the changing climate and safeguard the well-being of Homabay County residents.

The training carried out in the 40 Wards across the County highlighted local effects of climate change including decreased crop production leading to hunger, conflicts, soil erosion, and the spread of diseases caused by flooding. Additionally, the Committees were taught how to construct vulnerability assessment matrices and educated on hazard maps

to monitor climatic conditions in their respective areas such as strong winds, unreliable rainfall, long dry spells, increased temperatures, and heavy rainfall.

Climate change Director Roy Odongo implored the county residents to adapt to the impact of climate change by adopting climate-smart agricultural practices protecting the environment through proper and efficient waste management and preserving the available resources for future generations. The Ward Climate Change Committee consists of nine members drawn from the forty wards totalling 360 members across the County. The Ward Committees were constituted after the enactment of the Homabay County Climate Change Act 2022.



## HEALTH: COUNTY MOVING A GEAR ON HEALTHCARE

### FIF PAYING DIVIDENDS

The recently enacted Homa Bay County Facility Improvement Fund has begun paying off. In his routine support supervision tour of Rachuonyo County Hospital in Oyugis, Health Chief Officer Dr. Kevin Osuri launched some of the infrastructural development made possible by the hospital's own revenue through the FIF model.

Other than the secure gate that befits the hospital, the facility is also funding on its own the expansion of its laboratory, doing a new administration block, and erecting a concrete perimeter wall.

Magunga Level 4 Hospital in Suba South is another success story in utilizing the FIF by having its pharmaceuticals in a consistent supply through the fund.

Homa Bay County in May joined five other counties among them Makeni, Kisumu, and West Pokot in enacting the legislation that seeks to safeguard health facilities from over-reliance on external funding. The FIF Act gives the hospitals the mandate to spend their revenues at source.

**H**ealth facilities in the county with infrastructure development stalled from the previous regimes will have such completed or renovated to have such facilities operate optimally. This, the government will do before considering initiating new projects for those facilities.

While on support supervision in health facilities in Suba South sub-county, County Chief Officer for Public Health and Medical Services Dr. Kevin Osuri revealed his department's plan, saying that it would be unsound to continue wasting public resources on stalled projects. "If a facility has a maternity wing or something like that not being utilized because it was never completed by whoever started it, we are going to complete them and put them into good use to serve our people."

Magunga Level 4 Hospital has a maternity unit which was started in 2003 and has never been completed to date. Obanga Health Centre has no operational maternity ward yet a 20-bed both male and female maternity has been lying fallow since 2016. Kisegi Level 4 Hospital has a 1980s-era multi-purpose block that is not being utilized due to its dilapidated state. These, among others, will be redone to good use by the facilities.

## ENDING TRIPLE THREAT: ZEROING-IN ON ERADICATING HIV

**H**oma Bay Governor H.E Gladys Wanga made an impactful appearance at the Maisha Conference 2023 closing ceremony in Mombasa, joining esteemed leaders such as Ms. Mary Muthoni, HSC, PS for State Department for Public Health and Professional Standards.

Governor Wanga, who also serves as the Vice Chair of the Health Committee of the COG, took on the role of Champion of the Triple Threat and Triple Elimination Initiative. This initiative, first initiated in Homa Bay, aims to reduce new HIV infections, teenage pregnancies, and gender-based violence by 75% by 2027.

Governor Wanga emphasized that the country's ultimate goal is to eradicate AIDS by 2030. She believes this objective can be accomplished through strategic partnerships and active community engagement.

"By joining forces, we can create a future where these preventable challenges are eradicated, allowing everyone to thrive," expressed Governor Wanga.

During the ceremony, the PS for Health, Ms. Mary Muthoni, praised leaders from both levels of

# SGBV POLICY: COUNTY BEGINS IMPLEMENTATION

The County Government of Homa Bay has begun the dissemination of the Homa Bay County Sexual and Gender-Based Violence Policy to the stakeholders and community gatekeepers as it moves to curb SGBV within the county. The dissemination workshop began in early August at the inter-departmental level and before it roped in sub-county stakeholders from all 9 sub-counties in Homa Bay. This program is sponsored in conjunction with PATH International.

The policy framework developed by the County Government of Homa Bay is coherent with the international, national, and regional legislative and policy frameworks to which Kenya is a signatory as provided in Article 2(6) of the Constitution of Kenya 2010. The policy seeks to protect women, men, boys, and girls against sexual harassment, sexual exploitation, and violence based on gender and social status, and other aggravating overtures based on one's gender.

The Homa Bay County SGBV Policy framework will strengthen mechanisms and strategies that enhance accountability, coordination, monitoring, and evaluation of sustainable SGBV programs



and projects while enhancing partnerships for a comprehensive response to increasing incidences of SGBV in the county.

It also proposes to adopt a robust and comprehensive referral mechanism that will be integrative and collaborative by ensuring that the survivors' and perpetrators' rights are properly entrenched in the community set up for the purpose of rehabilitation and restoration.

They lauded the county government under the stewardship of Governor Wanga for the efforts and interventions around the blue economy that have already been initiated. Mr. Kundu and his team were in the county as part of the assessment on landing site projects along the lakefront counties. While appreciating the state for seeking to work with the counties to improve blue economy outcomes, Governor Wanga mentioned that the County is moving with speed to put up modern fish landing sites and urged the State to expedite their facilitation towards the same, to follow on to the commitment by the President on the lake-front regeneration projects that need to be launched later in the year.
