

# 2.0 KEY HIGHLIGHTS IN THE HOMA BAY COUNTY URBAN INSTITUTIONAL DEVELOPMENT STRATEGY

### 2.1 BACKGROUND

Section 108 of the County Government Acts, 2012 provides that each County Integrated plan shall at least identify; as informed by the strategies and program in the plan any development initiatives in the county including institutional development.

The Homa Bay County Institutional Development Strategy (CUIDS) outlines the overall approach to urban areas management as well as the process by which the County Government integrates urban development into County- wide planning.

The CUIDS goes ahead to specify how the county intends to address urban management issues and includes an annual action plan and budget outlining the proposed use of Urban Institutional Grants(UIG).

Through the provision of UIGs the County government aims to promote urban development within the county by establishing and strengthening urban institutions (for example Municipal boards and Municipal administrations) and by integrating urban development challenges and opportunities into county- wide development strategies and plans.

### 2.2 Urbanization and County Socio-economic development

Interdependence and connections between rural and urban areas in the county exist in the following key ways:

Economic Interactions: Rural areas often serve as primary producers of agricultural commodities, raw materials, and natural resources, which are then processed, manufactured, or consumed in urban areas. Urban areas, in turn, provide markets, infrastructure, services, and employment opportunities for rural populations. These economic interactions involve the flow of goods, services, capital, and labor between rural and urban areas.

Market Connections: Rural areas rely on urban markets to sell their agricultural produce and other goods. Urban areas provide a concentrated consumer base with greater purchasing power, demand for specialized products, and diverse consumer preferences. Rural producers, on the other hand, supply food, raw materials, and other goods to urban markets, often through intermediary traders or cooperatives.

Supply Chains and Infrastructure: Transportation systems, such as roads, railways, and logistics hubs, facilitate the movement of goods and services between rural and urban areas.

Social and Cultural Exchanges: People from rural areas travel to urban areas for

contribute to the transfer of knowledge, skills, and cultural practices between rural and urban populations.

### 2.3 Urban Development challenges

- 1. Homa bay County has about 201Km of the road surface in the under bitumen and the rest of the classified road network of about 3041Km is not bitumized with 25 per cent under gravel and earth 75 per cent under earth. The County has five airstrips, namely: Kabunde, Mfangano, Rusinga, Otange and Otaro airstrip but only Kabunde airstrip has been upgraded to airport standards and is operational with three flights per week. In terms of water transport, the county still lags behind with 151 underdeveloped landing beaches. A ferry service is in operation connecting Mbita Point- Mfangano Island-LwandaKotieno. The harbors established by Kenya Railways in Homa Bay, Kendu-Bay and Kajimu need basic rehabilitation to become operational except for the one in Mbita and Mfangano Island which are in a state of disrepair. The county has neither a railway system nor a pipeline which can boost economic growth.
- 2. Waste management remains a major concern in Homa Bay County with the emerging need for sustainable development in the Lake Victoria basin. Most of the solid waste in the county remain uncollected leading to spread of infectious diseases, blocked sewers, litter in the streets and pollution of Lake Victoria through crude dumping of waste. Waste management in the five municipalities of Homa Bay, Mbita, Oyugis, Ndhiwa and Kendu Bay has been contracted out with great effect on service delivery. Moreover, going forward, the County Government is focused on improving solid waste management through an integrated approach that includes recycling and composting programmes.
- 3. The only known water supply schemes that are operational with frequent breakdowns are those in major urban centres such as Homa Bay, Mbita, Kendu Bay and Oyugis.
  Rehabilitation of both the old and new water intakes is on-going, and new pumps are being installed, resulting in a doubling of urban water production. Immediate works to reduce leaks and rehabilitate the treatment works at the reservoirs will help to reduce unaccounted-forwater from 65% to the present level of 41%.
- 4. The vast majority of housing units in the county are earth-floored (74.7 per cent), mud-wood walled (65.6 per cent) andiron-roofed (82.3 per cent). Through collaboration with the National Government under the National Housing Cooperation, Homa Bay County signed an MoU that will see the development of over 400 affordable housing units in Homa bay town.
- Inadequate technical capacity in important departments such as County Planning Unit and other complimentary technical departments has impaired

million per municipality that will fund the activities and functions of the urban institutions. Funding for the delineation of Rodi and Sindo rural centers has also been set aside. The county will have plans such as (IDEPS, ADP, FSP, CBROP, CIDP and Spatial plans) to give a basis for investment.

The municipality staff is recruited by the county public service board and their salaries also paid from the county budget. The board is held accountable by the County government (office of the Governor). Revenue collected by the Municipality is channeled to the County government

### 2.6.2 Legal and regulatory reforms at the county level

Section 9 (3b) of Urban and areas cities act 2011 amended in 2019 requires the towns to be conferred municipality status to have development plans. Homa bay and Oyugis municipalities have 'Integrated Urban Development Plans' and 'Local and Physical land use development plans'. Development plans for Mbita (ref no. HMB/380/01/1 of 2001), Ndhiwa (1973) and Kendu bay (1973) are due for review.

The formulation of the Solid waste management policy for Homa Bay County and plans for Oyugis and Homa bay municipalities is currently under way. County Climate Change policy is already in place and is being implemented in Homa bay Municipality.

Homa bay County Valuation and Rating act, 2020 is in use especially in Homa bay Municipality in mobilization of land rates. Plans to roll out the same in Oyugis Municipality are in place during the next financial year.

Section 9(3) (f) of the urban areas and cities act 2011 amended in 2019 requires towns applying for conferment of municipalities to have institutionalized active participation of residents in the management of their affairs. In this regard, the Municipalities have operationalized sub location and ward public participation barazas which are led by area chiefs and ward administrators.

### 2.7 Capacity building actions

To support changes in urban management, several capacity-building actions are required. Some key capacity-building actions that can be undertaken include:

Training and Workshops: Conduct training programs and workshops to equip urban managers and staff with the necessary skills and knowledge to handle new challenges and adopt innovative approaches.

Knowledge Sharing and Networking: Facilitate platforms for municipal managers to share experiences, best practices, and lessons learned. This can be done through conferences, seminars, webinars, and online communities.

Institutional Strengthening: Focus on enhancing the capacity of urban management institutions, such as local government agencies, urban planning departments, and municipal bodies. This includes improving governance structures, policy formulation, strategic planning, and financial management systems.

Data Collection and Analysis: Enhance the ability of municipalities to collect, analyze, and interpret data relevant to urban management. This includes training in

data-driven decision making.

Stakeholder Engagement: This in ale & terining urban manarase an tachniques for

engaging citizens, community groups, businesses, and other stakeholders in decisionmaking processes.

Sustainable Development Practices: Promote capacity building on sustainable development principles and practices in urban management. This includes training on topics such as green infrastructure, energy efficiency, waste management, climate change mitigation, and resilience planning.

**Policy and Legal Frameworks:** Strengthen capacity in understanding and implementing urban policies and legal frameworks. This includes training on urban legislation, land use planning regulations, zoning policies, and urban governance structures.

### 2.8 Public Participation

The Homa Bay and Oyugis municipalities Boards held public participation in both the municipalities. The Homa Bay Municipality Citizen Fora was held in the Municipality offices on 29<sup>th</sup> June, 2023. The Oyugis Municipality citizen Fora was held at the Sub- County Offices on 30<sup>th</sup> June, 2023.

Pursuant to Articles 10(2)(a), 174(c), 196(1)(b), of the Constitution of Kenya, 2010 and Section 87 of the County Governments Act, 2012, the Homa Bay County Assembly Lands, Physical Planning, Housing and Urban Development Committee, through the office of the clerk, invited the public, private sector organizations, interested parties and all stakeholders to submit any representation on the Homa Bay County Urban Institutional Development Strategy either orally or by written memorandum.

The advert appeared in the newspaper on Wednesday 2<sup>nd</sup> August, 2023 stating that, Written memorandum were to be forwarded and received by the office of the clerk on or before Wednesday 9<sup>th</sup> August, 2023 and public hearings were to be held in the County Assembly on Wednesday 9<sup>th</sup> August, 2023.
